

ABOUT COOKIES ON OUR WEBSITE

Axess Logistics* (in this policy referred to as “we”) uses cookies on the website.

In summary, we use cookies for the following purposes:

- [For analysis and development of the website – with your consent](#)
- [To display relevant marketing from us on other websites and platforms – with your consent](#)
- [So you can use our portal](#)
- [For website functionality and to remember your preferences](#)

You can find more detailed information about our use of cookies in the website’s cookie banner. For example, we have listed the names of cookies, the services we use, and how long each cookie is used under ‘Cookie Declaration’. You can find this by clicking on ‘Cookie Settings’ in the bottom-left corner of our website.

What are cookies?

By ‘cookies’, we mean all cookies, pixels, and similar tracking technologies that provide us with information about your device and store information on your device. Your personal data

When you use cookies on our website, we collect certain information that is considered personal data. To protect your privacy, we have taken measures to avoid identifying you as a website user. For example, your IP address is encrypted making it nearly impossible for us to track who you are. When we process data that can directly or indirectly be linked to you as an individual, we disclose that in our [privacy policy](#).

Third-party services and third-party cookies

We mainly use standard ‘http cookies’ but also employ more advanced pixel cookies and third-party cookies from various marketing service providers. Google may use the collected information for its own purposes, but our other providers do not use it for their own purposes and only act according to our instructions. In the information below and in our ‘Cookie Declaration’, we have linked to information on how third parties use cookies as far as possible.

Cookies we use after your consent

STATISTICS AND ANALYSIS: For analysing and developing the website

We use temporary and permanent cookies from Google to **analyse how the website is used** and to **improve it**.

By using cookies on the website, we obtain information about your IP address in encrypted form and gather data from your device during your visit to the site (such as how many people visit different pages, how long visitors stay on the site, which parts of our site are used, and which device is being used). Additionally, information that Google already has about you is used.

MARKETING: Showing you relevant advertising

We use cookies to display relevant marketing to you when you visit other websites and platforms, and to measure the effectiveness of our marketing. We do this with the assistance of marketing services from Google.

These tools allow you to see search results and advertising banners from us based on the analysis made of your use of our website, as well as other information our providers have about you (known as 'profiling').

If you block/delete these cookies, you will see less relevant marketing.

Your consent is voluntary

The cookies we use for these purposes are not absolutely necessary for the website to function, so we require your consent before using them when you visit the site. We will only use this type of cookie if you first choose to consent.

If you [block](#) cookies, we will have less reliable data to track website usage and fewer opportunities to improve the site. Blocking these cookies means you'll be asked again if you wish to accept them each time you visit our website.

Necessary Cookies

We use the necessary cookies for the functionality of our website and portal and to remember your preferences. Without these cookies, it will not be possible to use all parts of our website. If you choose to [block](#) this type of cookie, it may cause the website not to function optimally.

STRICTLY NECESSARY – To use our portal

Temporary cookies are used to **know if you are logged in** and to **keep track of your session**. These cookies are deleted once you close your browser.

We also use a cookie to ensure that the items you add to your basket stay there while you shop.

These cookies are necessary for the portal's functionality and we therefore do not require your permission to use these cookies.

STRICTLY NECESSARY – For the website's functionality and to remember your choices

Temporary and session cookies are used for the website's functionality and to remember your choices. The following cookies will be used when you visit our website. These cookies are essential to provide a service you have explicitly requested. They are necessary for the website to function correctly and to remember your preferences. Therefore, your consent is not required to place these cookies on your browser.

- To **ensure the website functions correctly**, cookies are used. A cookie is also used to track your session by generating a random ID. Cookies from our provider Parttrap and Microsoft are additionally used.
- We use cookies to **protect our website** from unauthorised content publication or similar attacks from third parties. These cookies are necessary for the website to function smoothly.
- In order to **ensure that our forms will work**, we make use of cookies from [Wufoo](#).
- To see **whether you have accepted the cookies** requiring your consent, we make use of Cookie-Script cookies. Cookie-Script provides our cookie banner, and the cookies associated with it ensure that analytics cookies are only used if you have given your consent through our cookie banner. This permanent cookie is necessary for the website's functionality and therefore does not require your consent to be used.

Opt out of cookies

You can block certain types of cookies by setting your browser to automatically reject them or to notify you whenever a website tries to save a cookie. Through your browser, you can also check which cookies have been saved and delete them. See your browser's help pages for more information.
